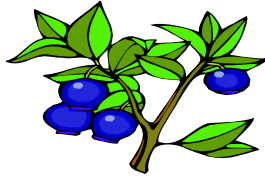

## **FOOD VENDORS**

**Efforts will be made to assure variety & avoid duplication. This means that if a BBQ, Italian, Chinese, Sandwich, or Ice Cream food vendor signs up by the time your application is received, there may not be a space for you. The cost of reserving a food vending space at the festival is \$ 100 per space. This includes \$ 50 fee for electric and water hookup. This fee is non-refundable. Payment of this fee is required before a food vending space can be secured. No set-up will be allowed without payment of the required \$100 fee and a completed indemnification agreement. Please plan to be set up by 6:00 PM Friday August 19, 2005.**

**ALL FOOD VENDORS ARE REQUIRED TO SIGN AND RETURN THE INDEMNIFICATION AGREEMENT BELOW, BEFORE AUGUST 1<sup>ST</sup>, 2005. WHICH MUST BE PROVIDED AT THE TIME PAYMENT IS MADE.**
